



## PUBLIC NOTICE

PUBLIC NOTICE IS HEREBY GIVEN by the undersigned, Director General and Clerk-Treasurer of the Municipality, that:

At the Council Meeting of the Municipality of Stanstead Township, held on December 2nd, 2024, the draft by-law entitled “**By-law number 482-2024 on the remuneration of elected officials, repealing By-laws 458-2022 and 476-2024**” was presented and a notice of motion was given with a view to its adoption at a subsequent council meeting.

This draft By-law provides for:

- This by-law repeals by-laws no. 458-2022 and 476-2024 concerning the salaries of elected municipal officials
- That the previous annual base remuneration of the mayor, was \$29,176 for the year in 2024, will increase to \$40,000 in 2025;
- That the annual base remuneration of a councillor was \$13,129 per year in 2024, rising to \$18,000 in 2025;
- That the annual base remuneration of a deputy mayor-councillor, which was \$13,785 per year in 2024, will increase to \$20,000 in 2025;
- Takes effect retroactively to January 1, 2025.
- If the mayor is replaced after 7 consecutive days, the deputy mayor is entitled to a sum equal to the mayor's remuneration during that period.
- That the Mayor receive, in addition to the remuneration payable under the present by-law, an allowance of \$19,422, the maximum amount eligible under the law, whereas it was \$14,588 in 2024.
- That each Council member continue to receive, in addition to the above-mentioned remuneration, an expense allowance in an amount equal to half of the above-mentioned remuneration as is currently the case.
- - That the above-mentioned remuneration and expense allowances will be indexed annually as of the fiscal year following the coming into force of the present by-law, according to the October CPI, published by Statistics Canada for the province of Quebec.
- - That the amount granted for attendance at various committees, i.e. \$60 for an elected committee member and \$90 for an elected committee chairman, remain the same for this year;
- - That the amount granted for citizen member attendance be increased to \$90 per citizen attendance and \$120 for citizen committee chairpersons;
- That this draft by-law be adopted by the municipal council of the Township of Stanstead at a regular meeting to be held on January 13, 2025 at 7:00 p.m. in the council chambers of the municipality of the Township of Stanstead, located at 778, rue Sheldon, Township of Stanstead.

This draft by-law is deposited at the Town Hall, where any interested person may examine it from Monday to Thursday, between 8:30 a.m. and 12 p.m. and between 12:30 p.m. and 4 p.m. and on Friday from 8:30 a.m. to noon or on the municipal website.
